## Chapter 3. Keywords for Uninstalling the Product

To uninstall this product, use the integrated uninstaller (uninstalls CS+). There are two ways to uninstall CS+.

- · Use the integrated uninstaller from Renesas (uninstalls all CS+ components)
- Use the Windows uninstaller (only uninstalls this product)

To use the Windows uninstaller, select the following from the Control Panel:

· Programs and Features

Then select [Renesas MCU Tools License Manager].

## Chapter 4. Points for Caution

## 4.1 Note on updating the version

After the license manager is updated to V2.00.00 or a later version, the setting for using a floating license is disabled by default. If you wish to use a floating license, enable this through the following step.

Click on the [Option] button in the [License Manager] window, and then click on the [Enable] button in the [Floating License Option] dialog box.

## Chapter 5. Changes

This chapter describes the main changes in the license manager from V1.25.00 to V2.00.00.

### 5.1 Providing method

The license manager was formerly provided with CS+ as a part of the CS+ utilities. It will be provided with CS+ as a separate license manager in V2.00.00 and later versions.

### 5.2 Management of licenses

License manager V2.00.00 and later versions manage both normal and floating licenses (client), although they were formerly handled by separate license managers. Accordingly, the window of the license manager displays [License Type] to make the distinction as shown below.

[Normal license]

Node Locked License (permanent)

Node Locked License (annual)

[Floating License]

Floating License

Floating License (Offline mode)

The manager now also supports annual licenses (\*). The window of the license manager displays [Expiration Date], which is blank when [License Type] is [Node Locked License (permanent)], but shows the date and time of expiration when [License Type] is [Node Locked License (annual)] or [Floating License].

(\*) Annual licenses will be released in 2017.




Figure 1 [License Manager] Window
